



**Memorandum of Understanding (MoU)
on Academic – Research and Technology
Cooperation
between**



Üsküdar University (UU)

&

Babol Noshirvani University of Technology (BNUT)

In order to promote mutual cooperation and to extend mutual understanding, both parties have reached the following understanding:

I- Üsküdar University and Babol Noshirvani University of Technology agree to cooperate on the following paragraphs, within the extent of each country's regulations and facilities.

- 1) Promotion of joint research works including exchange of faculty and research members.
- 2) Development of student exchange programs and organization of programs granting dual diplomas in conformity with the legislation of both countries upon approval from the Turkish Council of Higher Education.
- 3) Exchange of academic research data and related materials.
- 4) Cooperation in publication activities or cultural activities.
- 5) Organization of joint academic and scientific activities such as conferences, seminars, symposiums and congresses.

II- Exchanges done within the joint research works will be planned separately by taking into consideration each university's facilities and conditions; the rules and procedures of the exchange program will be determined in a separate MoU between the parties.

III- The academic exchanges described above will be limited to legislation in force in each country and to their respective budgetary resources.

IV- This MoU will not cause any binding financial obligation for either party.

V- Signature of this MoU will not cause any obligation for either party to enter into any specific understanding relating to cooperation between two universities.

VI- All intellectual property rights in respect of any research, products or services developed jointly by the Parties, which originate from this MoU, will be jointly owned by the Parties; Unless the Parties decide otherwise in written.

VII- The execution of this MoU will be subject to the laws in force in each parties' country. The parties are responsible for obtaining the required in-house or other approvals in accordance with the legislation they are subjected to.

VIII - This MoU, since the signing between the Parties, is valid for a period of five (5) years and will be automatically extended for the same periods; unless one of the Parties informs the other Party, through diplomatic channels in writing, of its intent to terminate this MoU, at least six (6) months prior to its intention.

IX -The provisions of this MoU may be amended with the written consent of the Parties through diplomatic channels and in the form of a joint committee. Termination or expiration of the terms of this MoU will not have any impact on the existing or ongoing programs and projects until their completion, unless the Parties decide otherwise in writing.

X -This MoU, comprising a preamble and 10 paragraphs, was signed in the cities of Babol and Istanbul on [date] and was made in two original versions in Persian and English languages, both texts being equally authentic. In case of any divergence in implementation or interpretation, English versions of the document will prevail.

This MoU will become effective after signing by the authorized representatives of both parties.

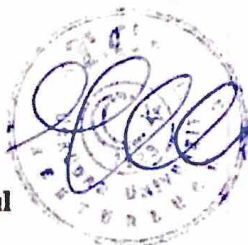
